The Town does not sell upright, flat or pillow markers. Rights Holders may, subject to any restrictions in the Town Cemetery By-law, install one (1) marker or monument on either Land Burial or Cremation In-Ground Lots at their own expense. Should you choose to purchase an upright marker, foundation pours occur twice a year; spring and fall based on weather conditions. All markers installed on a Lot are subject to a contribution for Care and Maintenance (C&M).
