### **Position Purpose:**

Under the direction of the Supervisor, Animal Services, the Municipal Law Enforcement Officer – Animal Services is responsible for administering, maintaining, and interpreting the Animal Services By-law, ensuring compliance, as well as other Municipal By-laws and provincial legislation relating to Animal Control for the Town of Whitchurch-Stouffville. The incumbent will assist with public relations activities, attend court to support charges laid, preserve public health and safety by removing vicious, diseased, and/or deceased animals, humane capture and impounding of animals found at large within the municipality. ## **Qualifications and Requirements:**

- Minimum of two (2) years related animal handling experience and behavioral.
- Thorough knowledge of the Dog Owners Liability Act, Provincial Offences Act, Municipal Act, and other
  pertinent legislation related to animal control, municipal law enforcement, and processes and practices
  including court documentation and proceedings.
- Excellent organizational skills.
- Proven investigative and report writing skills, verbal communication and presentation skills.
- Advanced interpersonal skills, with ability to interact effectively with all municipal staff, elected officials, residents and businesses.





- Problem-solving skills, discretion and good judgement when handling confidential/sensitive information and communicating with individuals regarding controversial matters; sensitivity and ability to maintain security of files.
