

# Town of Whitchurch-Stouffville Committee of Adjustment Schedule - 2025

# 1. Pre-Consultation Application for Minor Variances and Consent Applications

Town Staff strongly encourage that applicants complete the pre-consultation process prior to making application for Minor Variance and/or Consent particularly if you are unfamiliar with the process or uncertain about Staff supportability of your proposal.

### 2. Mandatory Preliminary Zoning Review (PZR) for Committee of Adjustment Applications

A Preliminary Zoning Review Notice (PZR) is <u>mandatory</u> for submitting a complete Committee of Adjustment Application. Please contact the Zoning Administrator in the Town's Building Department to request for a PZR <u>prior to the Material Deadline as noted in the table below, the PZR process may take up to ten (10) business days to complete. All requirements can be submitted as PDF by email to <a href="mailto-buildingpermits@townofws.ca">buildingpermits@townofws.ca</a>. Payment of fees to be paid by credit card. Planning Staff will take no responsibilities for any delays in obtaining the PZR from the Building Department. Committee of Adjustment Applications without a PZR Notice received for Planning Review, will not be accepted by the Planning Department.</u>

#### 3. Material Submission Deadline

Applications must be complete and received no later than 12:00 PM (Noon) on the Material Submission Deadline date. Applications not meeting this deadline will automatically be placed on the Agenda of the next Committee of Adjustment scheduled hearing/meeting.
